INTRODUCTION

SYNERGY MICROWAVE CORPORATION (“we” or “us” or “our”) respects the privacy of our users (“user” or “you”). We are not responsible for the actions of third parties with whom you share personal or sensitive data, and we have no authority to manage or control third-party solicitations. Your California Privacy Rights
